**JOINT MOTION TO ADMIT EVIDENCE AND REMAND
TO THE PUBLIC UTILITY COMMISSION OF TEXAS**

On July 31, 2019, Southwestern Public Service Company (“SPS”) and Staff of the Public Utility Commission of Texas (“Staff”) jointly, “the Signatories”) filed a Stipulation resolving all substantive issues in this proceeding. Texas Industrial Energy Consumers (“TIEC”) is unopposed to the Stipulation. Per the Signatories’ agreement, SPS files this Joint Motion to Admit Evidence and Remand to the Commission (“Motion”).


SPS respectfully requests the following be admitted into evidence:
