**I. ADOPTING PROPOSED PROCEDURAL SCHEDULE AND

On June 10, 2019, Southwestern Electric Power Company (SWEPCO) filed an Agreed Proposed Procedural Schedule and a Motion to Cancel Prehearing Conference scheduled for June 13, 2019. This request is **GRANTED**, and the following procedural schedule as set out below is **ADOPTED**. The briefing dates have been adjusted to ensure sufficient time for issuance of a final decision and to align with the December open meeting date.
