MOTION FOR EXTENSION OF TIME

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Motion for Extension of Time and would show the following:

I. BACKGROUND

On May 17, 2019, Quadvest, L.P. (Quadvest), filed an application to amend water certificates of convenience and necessity (CCN) No. 11612 and sewer CCN number 20952, and to decertify portions of Aqua Texas Inc.'s service area in Montgomery County pursuant to Texas Water Code (TWC) §§ 13.242 to 13.250 and the 16 Texas Administrative Code (TAC) §§ 24.225 to 24.237. The requested service area consists of approximately 208 acres with 852 current connections. On March 19, 2020, the Administrative Law Judge issued Order No. 8, establishing March 25, 2020 as the deadline for Staff to file a Joint Findings of Fact and Conclusions of Law on the application.

II. MOTION FOR EXTENSION OF TIME

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for the filing of any documents be extended for good cause. The final recommendation deadline for Staff was extended to provide time for Aqua Texas to file its consent form. As a result of the extended deadline for the final recommendation, Staff requests an extension to file Joint Findings of Fact and Conclusions of Law until April 22, 2020.

III. CONCLUSION

Staff respectfully requests the entry of an order consistent with the above.
