**COMMISSION STAFF'S MOTION FOR EXTENSION OF TIME**

**COMES NOW** the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Motion for Extension of Time and would show the following:

**I. BACKGROUND**

On May 17, 2019, Quadvest, L.P. (Quadvest), filed an application to amend water certificates of convenience and necessity (CCN) No. 11612 and sewer CCN number 20952, and to decertify portions of Aqua Texas Inc.'s service area in Montgomery County pursuant to Texas Water Code Ann. (TWC) §§ 13.242 to 13.250 and the 16 Texas Administrative Code (TAC) §§ 24.225 to 24.237. The requested service area consists of approximately 208 acres. On March 31, 2020, the Administrative Law Judge issued Order No. 9, establishing April 22, 2020 for parties to file joint findings of fact and conclusions of law. On April 22, 2020, Staff filed a motion for extension of time to file joint findings of fact and conclusions of law until April 27, 2020.

**II. MOTION FOR EXTENSION OF TIME**

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for the filing of any documents be extended for good cause. Staff requests an extension to file to file joint findings of fact and conclusions of law until May 11, 2020. Staff is currently working with all the parties for agreement on the joint findings of fact and conclusions of law, Staff has not yet heard from Aqua Texas, Inc. on any agreement.

**III. CONCLUSION**

Staff respectfully requests the entry of an order consistent with the above.
