FORTY 200 APARTMENT HOMES' RESPONSE TO ORDER NO. 1, ORDER NO. 2, AND ORDER NO. 3

FORTY 200 APARTMENT HOMES ("Respondent"), pursuant to P.U.C. Proc. R. 22.78 and Order No. 1, Order No. 2, and Order No. 3 (collectively "Orders") Requiring Responses to the Complaint of AMEENAH MUHAMMAD ("Complainant") in the above referenced proceeding, would respectfully show the Commission as follows:

I. The Commission's Jurisdiction Over this Proceeding

Respondent submits that the PUC has jurisdiction over this proceeding with respect to the water and sewer billing. The PUC does not have jurisdiction over any other charges assessed to Complainant.

II. Allegations Raised in the Complaint

Complainant complains his water and sewer bills are too high. Respondent bills Complainant based on the Public Utility Commission ("PUC") approved 50/50 method¹: 50% of his water and sewer bills are based on the square-footage of his unit compared to the total square-footage of the property, and 50% of his water and sewer bills are based on the number of occupants in his unit. Complainant resides in a 963 square-foot apartment and has four occupants. Respondent denies it has over billed Complainant for his water and sewer charges.
