- b. Please provide TNMP's forecasted 2020 kWh by class.
- c. Please reconcile the annual opt out kWhs with the annual opt out kWhs reflected on Exhibit SMC-2, Table 4.

RESPONSE:

- a. The heading that states: "Forcasted 2019 kWh" should state "Forecasted 2020 kWh". The industrial opt-out kWh are actuals. Industrial opt-out customers are typically not impacted by weather, such as residential customers.
- b. See the response to (a.) above.
- c. SMC-2, Table 4, reflects prior period filed EEPR data updated for the current year. The five year data under WP Billing units pulls the historical data for the eligible out-outs. If prior industrial opt-outs are not renewed, the data is removed. If new industrial opt-outs have prior data, that amount is added to prior years. SMC-2, Table 4, for 2018 inadvertently left out the lighting kWh that is reflected in WP Billing units.

SUPPLEMENTAL RESPONSE:

The data referenced in response to Cities 1-4(a) is weather normalized over a 20 year period. Additionally, the "Forecasted 2019 kWh" is available in TNMP's prior EECRF docket, Application of Texas-New Mexico Power Company to Adjust its Energy Efficiency Cost Recovery Factor, Docket No. 48404 (Oct. 12, 2018).

SECOND SUPPLEMENTAL RESPONSE:

For clarity, TNMP's demand-reduction goal is weather adjusted using weather data for the most recent 10 years, as required by § 25.181(e)(3). The 20 year period discussed above refers to the forecasted billing determinants.
