

SOAH ORDER NO. 3 GRANTING AMENDED JOINT MOTION TO ADMIT EVIDENCE AND REMAND PROCEEDING

On September 4, 2019, Applicant Texas-New Mexico Power Company (TNMP), with the consent and approval of the staff (Staff) of the Public Utility Commission of Texas, and Cities Served by TNMP (Cities, and collectively Joint Movants) filed an Amended Joint Motion to Admit Evidence and Remand Proceeding to the Commission (Amended Joint Motion). The Joint Movants represent that the parties have reached agreement on and resolved all issues in this case and there is no longer any need for a contested case hearing. The Amended Joint Motion is granted.
