- 1. Cities are municipalities located within the service territory of Texas-New Mexico Power Company (TNMP). Cities as well as their residents and businesses may be adversely impacted by the relief requested by TNMP regarding its energy efficiency cost recovery factor.
- 2. Additionally, Cities have standing pursuant to Public Utility Regulatory Act (PURA) § 33.025.<sup>2</sup>
