#### COMMISSION STAFF'S CLARIFICATION ON RECOMMENDATION

**COMES NOW** the Commission Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Clarification on Recommendation. Staff does not recommend that notice be published in a newspaper of general circulation. In support thereof, Staff shows the following:

#### I. BACKGROUND

On June 7, 2019, MSEC Waste Water Inc. (MSEC Waste) and MSEC Enterprises Inc. (MSEC Enterprises)(collectively, Applicants) filed an application for Sale, Transfer, or Merger of Facilities and Certificate Rights in Montgomery County, Texas. Specifically, MSEC Waste seeks approval to purchase facilities and transfer MSEC Enterprises' wastewater Certificate of Convenience and Necessity (CCN) No. 20984. The requested area includes approximately 373 total acres and 3 current customers.

On July 10, 2019, Order No. 2 was issued asking for clarification of whether Staff was recommending that notice be published in this case. Therefore, this pleading is timely filed.

#### II. CLARIFICATION ON NOTICE RECOMMENDATION

The memorandum of Debbie Reyes, filed on July 3, 2019 with Staff's Recommendation on Administrative Completeness and Proposed Procedural Schedule, mistakenly included a request for a publisher's affidavit for proof of newspaper publication. Staff does not recommend published notice in this case.
