**SOAH ORDER NO. 2
ADOPTING AGREED PROCEDURAL SCHEDULE;

Any of the foregoing deadlines may be modified by written agreement of all parties filed with the ALJ, except the dates for the prehearing conference and the hearing on the merits, which may only be modified by order of the ALJ upon proper motion.
