## COMMISSION STAFF'S SUPPLEMENTAL RECOMMENDATION ON ADMINISTRATIVE COMPLETENESS AND PROPOSED NOTICE

**COMES NOW** the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and in response to Order No. 3, files this Supplemental Recommendation on Administrative Completeness and Proposed Notice. Staff recommends that the application be deemed sufficient for further review. In support thereof, Staff shows the following:

#### I. BACKGROUND

On June 21, 2019, NI America Texas, LLC and Monarch Utilities I L.P. (collectively, Applicants) filed an application for approval of the sale, transfer, or merger of sewer facilities and certificate rights (CCN) in Johnson and Wise counties. Specifically, the applicants seek to transfer all of NI America Texas's water service area to Monarch's water service area and the cancelation of NI America Texas's CCN number. The requested transfer area includes approximately 5,225 acres with 1,166 current customers. The Applicants filed supplemental information on August 22, September 6, and September 11, 2019.

On July 23, 2019, Order No. 3 was issued establishing a deadline of September 23, 2019 for Staff to file a supplemental recommendation on the administrative completeness of the application and notice and propose a procedural schedule for further processing of the application. Therefore, this pleading is timely filed.

#### II. ADMINISTRATIVE COMPLETENESS

As detailed in the attached memorandum from Elizabeth English in the Commission's Infrastructure Division, Staff has reviewed the application and supplemental information filed by the Applicants and recommends that it be found administratively complete.

## III. NOTICE

The Commission's notice requirement for sale, transfer, merger applications are provided by 16 Texas Administrative Code § 24.239. Specifically, Staff recommends the Applicants be ordered to provide notice according to the attached memorandum of Elizabeth English.

## IV. PROCEDURAL SCHEDULE

Staff recommends the application, as supplemented be found administratively complete. Staff therefore proposes the following procedural schedule:

Event	Date
Deadline for the Applicants to file with the Commission signed affidavits that notice was given along with a copy of the notice sent to the affected parties	October 23, 2019
Deadline for Staff to file a recommendation on sufficiency of notice	Within ten (10) days of the Applicants filing proof of completed notice with the Commission
Deadline for intervention and for intervenors to request a hearing on the merits	Thirty (30) days after notice is issued

## V. CONCLUSION

For the reasons discussed above, Staff respectfully recommends that the application, as supplemented be found administratively complete, that the Applicants be directed to provide notice as detailed in the attached memorandum, and that the procedural schedule proposed above be adopted.

On June 21, 2019 Ni America Texas, L.L.C. (Ni America or Seller) and Monarch Utilities I L.P. (Monarch or Purchaser) (collectively, Applicants) filed an application for the Sale, Transfer, or Merger (STM) of facilities and certificate rights in Johnson and Wise Counties, Texas, pursuant to Texas Water Code §§ 13.301 and § 13.246, and the 16 Texas Administrative Code § 24.239. Specifically, the Applicants seek approval to acquire facilities and for the transfer, and cancellation, of Ni America's Certificate of Convenience and Necessity (CCN) No. 11922. The CCN and the associated seven public water systems are to be transferred to Monarch's CCN No. 12983.

and Monarch Utilities I L.P. Rights in Johnson and Wise

The Applicants filed supplemental information, as requested by Staff, on August 22, September 6, and September 11, 2019. Based upon the supplemental filings, Staff now recommends that the STM application be deemed administratively complete and accepted for filing. Specifically, in regard to mapping, the second page of the general location map and the detailed maps filed on August 22, 2019, and the first page of the general location map filed September 11, 2019 are sufficient in meeting Commission requirements.

Staff further recommends that the Applicants:

- 1) Provide notice of the application to the following:
  - a) cities, districts, and neighboring retail public utilities providing the same utility service whose corporate boundaries or certificated service area are located within two miles from the outer boundary of the requested area;
  - b) the county judge of each county that is wholly or partially included in the requested area;
  - c) each groundwater conservation district that is wholly or partially included in the requested area; and
  - d) affected customers
- 2) Provide correct notice of the application to the following:

**Shaded Lane Estates:** The requested area is located approximately <u>4.8</u> miles <u>southeast</u> of downtown <u>Burleson</u>, TX, and is generally bounded on the north by <u>CR 529</u>; on the east by <u>CR 608</u>; on the south by <u>CR 528</u>; and on the west by <u>Merrell Court</u>.

The requested area includes approximately <u>198</u> total acres and <u>243</u> current customers.

# Wise County

**Chisholm Hills Estates:** The requested area is located approximately <u>1.6</u> miles <u>north</u> of downtown <u>New</u> <u>Fairview</u>, TX, and is generally bounded on the north by <u>1,000 feet north of Chisholm Hills Drive</u>; on the east by <u>FM 2264</u>; on the south by <u>500 feet south of Wilson Court</u>; and on the west by <u>600 feet west of Layfield Lane</u>.

The requested area includes approximately <u>724</u> total acres and <u>269</u> current customers.

*Coyote Ridge Addition, Sage Brush Estates, and Hills of Oliver Creek:* The requested area is located approximately <u>3</u> miles <u>north</u> of downtown <u>New Fairview</u>, TX, and is generally bounded on the north by <u>FM 2264</u>; on the east by <u>FM 2264</u>; on the south by <u>2,000 feet south of Happy Trail</u>; and on the west by <u>CR 4421</u>.

The requested area includes approximately 3,244 total acres and 508 current customers.

Las Brisas: The requested area is located approximately <u>4</u> miles <u>southwest</u> of downtown <u>Decatur</u>, TX, and is generally bounded on the north by <u>Eastridge Road and Waggoner Creek</u>; on the east by <u>Wild</u> <u>Wood Drive and Acorn Drive</u>; on the south by <u>Hlavek Road</u>; and on the west by <u>Mission Oak Trail</u>.

The requested area includes approximately 233 total acres and 0 current customers.

*Sky View Ranch Estates:* The *two requested areas* are located approximately <u>3</u> miles <u>northeast</u> of downtown <u>Rhome</u>, TX, and is generally bounded on the north by <u>3,200 feet north of intersection of FM</u> <u>407 & Pioneer Road</u>; on the east by <u>FM 2264</u>; on the south by <u>FM 407/ Illinois Street</u>; and on the west by <u>US Highway 287</u>.

The requested area includes approximately <u>356</u> total acres and <u>71</u> current customers.

*Windmill Trail:* The requested area is located approximately <u>7.4</u> miles <u>southeast</u> of downtown <u>Bridgeport</u>, TX, and is generally bounded on the north by <u>Garrett Creek</u>; on the east by <u>CR 3355/ School</u> <u>House Road</u>; on the south by <u>CR 3355/ School House Road</u>; and on the west by <u>CR 3473</u>. The requested area includes approximately <u>527</u> total acres and <u>75</u> current customers.

If no settlement is reached and an evidentiary hearing is held, SOAH will submit a recommendation to the Commission for final decision. An evidentiary hearing is a legal proceeding similar to a civil trial in state district court.
