

*Sky View Ranch Estates:* The *two requested areas* are located approximately 3 miles northeast of downtown Rhome, TX, and is generally bounded on the north by 3,200 feet north of intersection of FM 407 & Pioneer Road; on the east by FM 2264; on the south by FM 407/ Illinois Street; and on the west by US Highway 287.

The requested area includes approximately 356 total acres and 71 current customers.

*Windmill Trail:* The requested area is located approximately 7.4 miles southeast of downtown Bridgeport, TX, and is generally bounded on the north by Garrett Creek; on the east by CR 3355/ School House Road; on the south by CR 3355/ School House Road; and on the west by CR 3473. The requested area includes approximately 527 total acres and 75 current customers.

You must send a letter requesting intervention to the commission which is received by that date.*

If a valid public hearing is requested, the Commission will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, SOAH will submit a recommendation to the Commission for final decision. An evidentiary hearing is a legal proceeding similar to a civil trial in state district court.
