To the Commission Staff:

Order No. 3 issued by the Administrative Law Judge on July 23, 2019 found the above referenced application incomplete and deficient. The applicants (Monarch) were ordered to supplement and cure the deficiencies on or before August 22, 2019. This is Monarch's response with additional information and documentation requested by the Commission staff in its July 22, 2019 memo. This response is timely filed.

Mapping

The general location and detailed maps must label each of the requested areas to be transferred as described in Question 30 (H) of the application. A portion of the requested area to be transferred was not shown on the detailed map.

The Applicants must submit the following items to resolve the mapping deficiencies:

- A general location map identifying only the requested area, in reference to the nearest county boundary, city, or town.
- A detailed map identifying only the requested area, in reference to verifiable man-made and natural landmarks, such as roads, rivers, and railroads.

Response: Attached are revised versions of the General Location Maps for Wise and Johnson Counties with the individual requested areas identified. Also attached are detailed maps with only the requested areas individually shown. A separate map of the entire Sky View Ranch system, previously shown only partially, is included.

Please note that this application is to transfer all existing service areas under CCN 11922 to CCN 12983. No changes or additions to current boundaries are requested.

Water System Details

The following information must be provided by the Applicants:



- The installation date, original cost, and accumulated depreciation for each asset listed in response to be transferred.
- The asset details must be reconciled with the totals provided in response to question 14 of the application.

Response: Filed separately under confidential seal is the list of individual asset cost data that corresponds to the information provided in section 14 of the application.

With this additional information, Monarch respectfully requests this transfer application be accepted and continue to be processed in a timely manner. Please contact me if any additional information is required at this time.








Coyote Ridge, Hills of Oliver Creek, Sage Brush






