COMMISSION STAFF'S REQUEST FOR EXTENSION

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Commission Staff's Request for Extension. In support thereof, Staff would show the following:

I. BACKGROUND

On July 1, 2019, Perry Water Supply Corporation (Perry) and Tri-County Special Utility District (Tri-County) (collectively, Applicants) filed an application for sale, transfer, or merger (STM) of facilities and certificate rights in Falls, McLennan, Robertson, and Limestone counties. Specifically, the applicants seek to transfer all of Perry's facilities and water service area under Certificate of Convenience and Necessity (CCN) No. 11129 to Tri-County's water CCN No. 10054 and to subsequently cancel CCN No. 11129. The service area to be transferred includes 606 acres and 136 current customers.

On August 6, 2020, Order No. 11 was issued, requiring the parties to file an agreed motion to admit evidence and joint proposed notice of approval by September 4, 2020. Therefore, this pleading is timely filed.

II. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff has reviewed the consent forms filed by the Applicants on July 22, 2020 and discovered several clerical errors. In order to allow time for the parties to ensure that all necessary information is correct before requesting that it be admitted into the evidentiary record, Staff respectfully requests that the deadline for the parties to

file an agreed motion to admit evidence and joint proposed notice of approval be extended until September 18, 2020.

III. CONCLUSION

Staff respectfully requests that the deadline for the parties to file an agreed motion to admit evidence and joint proposed notice of approval be extended until September 18, 2020.
