



STATEMENT UNDER SECTION 4 OF PROTECTIVE ORDER

Certain documents provided in response to the Office of Public Utility Counsel's (OPUC) First Request for Information to Southwestern Electric Power Company (SWEPCO), Question No. 1-8 are exempt from public disclosure pursuant to Sections 552.101, 552.104, and 552.110 of the Public Information Act¹ and are subject to treatment as Confidential materials.

The materials provided in response to OPUC's RFI No. 1-8 contain non-public commercially sensitive operational data, comparisons and compilations, that if released, would provide an advantage to a competitor or bidder and could cause substantial competitive harm to SWEPCO.

Counsel for SWEPCO has reviewed the documents sufficiently to state in good faith that the documents are exempt from disclosure under the Public Information Act and merit the Confidential materials designation given to them.
