STATEMENT UNDER SECTION 4 OF PROTECTIVE ORDER

Certain documents provided in response to Golden Spread Electric Cooperative Inc.'s (GSEC) First Request for Information to Southwestern Electric Power Company (SWEPCO), Question No. 1-31 are exempt from public disclosure pursuant to Sections 552.101, 552.104, and 552.110 of the Public Information Act¹ and are subject to treatment as Highly Sensitive protected materials.

The materials provided in response to GSEC Question No. 1-31 contain information pertaining to the Company's internal projections and analyses that if released, would provide an advantage to a competitor or bidder and could cause substantial competitive harm to SWEPCO.

Counsel for SWEPCO has reviewed the documents sufficiently to state in good faith that the documents are exempt from disclosure under the Public Information Act and merit the Highly Sensitive designation given to them.




