**STATEMENT UNDER SECTION 4 OF PROTECTIVE ORDER**

Certain documents provided in supplemental response to Texas Industrial Energy Consumers' (TIEC) Second Request for Information to Southwestern Electric Power Company (SWEPCO), Question No. 2-23 are exempt from public disclosure pursuant to Sections 552.101, 552.102, 552.104, and 552.110 of the Public Information Act<sup>1</sup> and are subject to treatment as Highly Sensitive protected materials.

The materials provided in supplemental response to TIEC's RFI No. 2-23 contain non-public commercially-sensitive contract terms, provisions, financial, and various operational data, that if released, would provide an advantage to a competitor or bidder and could cause substantial competitive harm to SWEPCO.


Counsel for SWEPCO has reviewed the documents sufficiently to state in good faith that the documents are exempt from disclosure under the Public Information Act and merit the Highly Sensitive materials designation given to them.


