STATEMENT UNDER SECTION 4 OF PROTECTIVE ORDER

Certain documents provided in supplemental response to Texas Industrial Energy Consumers' First Request for Information to Southwestern Electric Power Company (SWEPCO), Question No. 1-16 are exempt from public disclosure pursuant to Sections 552.101, 552.104, and 552.110 of the Public Information Act¹ and PURA § 32.101(c) and are subject to treatment as Confidential protected materials.

The materials provided in supplemental response to TIEC 1-16 contain non-public, commercially sensitive, compilations of Company financial and operational data, economic analyses, forecasts and projections, and confidential customer information, including expected load, usage, and pricing data, that if released, would provide an advantage to a competitor or bidder and could cause substantial competitive harm to SWEPCO.

Counsel for SWEPCO has reviewed the documents sufficiently to state in good faith that the documents are exempt from disclosure under the Public Information Act and merit the Confidential materials designation given to them.
