STATEMENT OF INFORMATION

COMES NOW, Horseshoe Bend Water Company LLC ("HBWC") and Patterson Water Supply. LLC ("Patterson") and file this Statement of Information with respect to Docket No. 49759.

EXPLANATORY NOTE

IIBWC has not been admitted as a party in this proceeding but is a party in Docket No. 50085 before the Public Utility Commission ("Commission") under Texas Water Code §13.301 (Report of Sale, Merger, Etc.), pursuant to which HBWC has acquired the public water system which is the subject of this proceeding. Pursuant to Texas Water Code §13.046(d), the temporary rates determined pursuant to this proceeding may be applied for a "reasonable period" after the acquisition of a nonfunctioning retail water utility and thus HBWC has an interest in this proceeding.

II. BACKGROUND

On December 15, 2020 the staff (the "Staff") of the Public Utility Commission of Texas filed a "Notice of Filing In Docket No. 50085 (the "Notice Filing") in Docket No. 49759 which notified the Commission of certain information filed by HBWC in Docket No. 50085 which was relevant to Docket No. 49759. The Notice Filing also raised a factual discrepancy regarding meter size in information filed pursuant to Docket No. 49759 and asked Patterson and HBWC to resolve the discrepancy

III. METER SIZE

HBWC and Patterson have not physically inspected each meter in the system. However, Patterson has physically inspected over 100 of the system's meters (representing approximately 25% to 33% of the system's active installed meters) and each meter inspected has been verified as 5/8" x 3/4". Based upon the results of this sample, Patterson and HBWC believe that all of the system's meters are 5/8" x 3/4". As of the end of the December 2020 billing period, the system had 503 active customer meters
