When you are ready to get started, select the Franchise Tax Accountability Questionnaire under Other Electronic Reporting Tools. Select "continue to log in" at the bottom of the page to sign in. You will need the WebFile number located at the top of this letter.

The company's first franchise tax report is due on 05/15/2018. We will send you a reminder letter with filing instructions well before the due date. You can contact our office for assistance at 1-800-252-1381.
