COMMISSION STAFF'S RECOMMENDATION

COMES NOW the Commission Staff of the Public Utility Commission of Texas (Staff) representing the public interest and in response to Order No. 1 files this, Commission Staff's Recommendation. In support thereof, Staff shows the following:

I. BACKGROUND

On August 1, 2019, Entergy Texas, Inc. (ETI), filed a non-standard true-up as the servicer of transition bonds issued pursuant to the financing order in Docket No. 37247.¹ ETI requests the System Restoration Costs (SRC) rates be adjusted for billing period 11 (November 2019 – October 2020).

Order No. 1 was issued on August 8, 2019, setting as September 3, 2019, a deadline for Staff to file comments on the proposed notice and proposed scope of the proceeding; propose a procedural schedule; and address other matters relating to the processing of the application. Therefore, this pleading is timely filed.

II. NOTICE

In accordance with Finding of Fact No. 88(b) in the Financing Order of Docket No. 37247, ETI is required to provide notice of this non-standard true-up to all parties in Docket No. 37247.² Staff has reviewed the certificate of service attached to the petition and recommends that the proposed notice be deemed sufficient.

III. PROCEDURAL SCHEDULE

Finding of Fact No. 88(a) of the Financing Order in Docket No. 37247 requires ETI to file its non-standard true-up at least 90 days before the due date of the proposed true-up adjustment.³ ETI filed its non-standard true-up on August 1, 2019—91 days before its proposed effective date of October 30, 2019. Consequently, Staff recommends that the following procedural schedule proposed by ETI be adopted.

Event	Date
Deadline for intervention:	August 30, 2019
Deadline to request a hearing:	September 6, 2019
If a hearing is not requested, deadline for parties to submit a proposed Order, including Findings of Fact, Conclusions of Law, and Ordering Paragraphs.	September 13, 2019

IV. CONCLUSION

Staff respectfully requests an order consistent with the above recommendations.


