**COMMISSION STAFF'S REQUEST FOR EXTENSION**

**COMES NOW** the Staff of the Public Utility Commission of Texas (Staff), representing the public interest and files this request for extension and would show the following:

**I. BACKGROUND**

On August 16, 2019, Alamo Mission LLC (Alamo) filed a petition for expedited release of approximately 166.594 acres from Rockett Special Utility District's (Rockett's) water certificate of convenience and necessity (CCN) No. 10099, in Ellis County, under Tex. Water Code (TWC) § 13.254 and 16 Tex. Admin. Code (TAC) § 24.245(l).

On September 17, 2019, the Commission administrative law judge (ALJ) issued Order No. 2, deeming the petition administratively complete. Thereafter, on September 26, 2019, Staff filed its final recommendation to approve Alamo's petition. On October 2, 2019, the Commission ALJ issued Order No. 4, requiring Staff to file comments on the information submitted by Alamo and Rockett subsequent to Staff's final recommendation by October 9, 2019. On October 4, 2019, Alamo filed additional information. This pleading, therefore, is timely filed.

**II. REQUEST FOR EXTENSION**

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requires more time to review the information filed by Alamo on October 4, 2019. As such, Staff requests that the deadline to file its recommendation be extended to October 11, 2019. Alamo has indicated that they are unopposed and Staff has attempted to communicate with Rockett, but Rockett has not replied at this time.

### **III. CONCLUSION**

Staff respectfully requests and order consistent with the foregoing.
