RE: Docket No. 49879 - Application of Swift Water Supply Corporation to Amend its

Water Certificate of Convenience and Necessity in Nacogdoches County

On August 21, 2019, Swift Water Supply Corporation (Swift) filed with the Public Utility Commission of Texas (Commission) an application to amend its water certificate of convenience and necessity (CCN) No. 11420 in Nacogdoches County, Texas pursuant to Texas Water Code (TWC) §§ 13.242 to 13.250 and the 16 Texas Administrative Code (TAC) §§ 24.225 to 24.237. The total service area being requested includes approximately 3,123 acres and 62 current customers.

The application was deemed sufficient on April 15, 2020. On May 27, 2020, Swift filed revised maps to remove an opt out request, and on May 27 and July 9, 2020, Swift filed proof of notice. The notice and revised mapping were deemed sufficient on August 3, 2020. After the adjustments were made the requested area was reduced to approximately 2,754 total acres and 62 current customers.

On September 29 and 30, 2020, Swift responded to Staff's requests for information (RFI) regarding the need for service in the requested area. Staff has reviewed the maps and worksheet with parcel data provided by Swift and recommends further revisions to the requested area to remove parcels that do not have requests for service or customers.

For Part A, Staff requests the following parcels be removed:

- 1) 8834
- 2) 8842
- 3) 9734
- 4) 9738

For Part B, Staff requests the following parcels be removed:

- 1) 13868
- 2) 7711
- 3) 7709
- 4) 7710
- 5) 10827
- 6) 13862
- 7) For parcel 10827, Staff suggests drawing a line straight down from the western border of 10827 straight down to the current CCN area.


Once these parcels are removed Staff recommends that Swift submit the following:

- a. A revised detailed map identifying the requested area after removing the parcels of land identified above.
- b. Revised digital mapping data in a shapefile format georeferenced in either NAD 83 Texas State Plane Coordinate System (US Feet) or in NAD 83 Texas Statewide Mapping System (Meters) for the revised requested area, after removing each tract of land Staff has mentioned above.
 - The digital mapping data must include a single, continuous polygon record for the revised requested area; and
- c. The total acreage for the revised requested area after removing the tracts of land Staff identified above. The total acreage for the revised requested area must correspond to the total acreage included with the digital mapping data included above in part b. 1,968.72 Acres


