COMMISSION STAFF'S REQUEST FOR EXTENSION AND AMEND PROCEDURAL SCHEDULE

COMES NOW the Staff of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Commission Staff's Request for Extension and Amend Procedural Schedule. In support thereof, Staff shows the following:

I. BACKGROUND

On August 27, 2019, Republic Business Center LLC (Republic or Petitioner) filed an application for expedited release from Aqua Texas, Inc.'s (Aqua) water Certificate of Convenience and Necessity (CCN) No. 13203 and sewer CCN No. 21065 in Harris County under Texas Water Code § 13.254(a-5) and 16 Texas Administrative Code § 24.245(l).

On October 18, 2019, Order No. 3 was issued, directing Aqua Texas and intervenors to file a response to the administratively complete petition by October 25, 2019, and Staff to file a recommendation on final disposition by November 1, 2019. Therefore, this pleading is timely filed.

II. STAFF'S REQUEST FOR EXTENSION

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff needs additional time to review Aqua Texas supplemental filing made in this docket. As such, Staff proposes to amend the procedural schedule as follows:
