

P.S. If the silence continues, then I recommend you bring someone -- a friend or a date -- with you to these gatherings. At least you will have omeone to talk to.




DEAR PONDERING: A subtle way to ask that question would be, "Congratulations! What's your lucky fiance's (-ee's) name?"


