COMMISSION STAFF'S REQUEST FOR EXTENSION

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest and files this request. In support thereof, Staff would show the following:

I. BACKGROUND

On September 3, 2019, Crystal Clear Special Utility District (Crystal Clear) filed an application to amend its sewer Certificate of Convenience and Necessity (CCN) No. 21086 in Comal, Hays, and Guadalupe Counties. The application was filed pursuant to Tex. Water Code § 13.242-.250 and Tex. Admin. Code (TAC) § 24.225-.237.

On February 21, 2020, Order No. 7 was issued, requiring Crystal Clear to file signed consent forms with the Commission by May 5, 2020. This pleading, therefore, is timely filed.

II. REQUEST FOR EXTENSION

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff and Crystal Clear have conferred on the need to extend the deadline to file consent forms. As such, Staff requests that the deadline to file signed consent forms with the Commission to May 8, 2020.
