## I. REQUEST FOR HEARING

- 1. On January 24, 2020, the City requested a hearing on the Applicant's request to amend its sewer CCN. A hearing on the Application has not occurred.
- 2. The Administrative Law Judge herein Ordered the City to indicate its desire for hearing in this proceeding by June 1, 2020. This pleading is timely filed.
