**COMMISSION STAFF'S MOTION FOR DOCKETING IN RESPONSE TO
SEVERANCE AND REMAND OF UNCONTESTED NAME CHANGE**

On September 3, 2019, Crystal Clear Special Utility District (Crystal Clear) filed an application to amend its sewer Certificate of Convenience and Necessity No. 21086 in Comal, Hays, and Guadalupe Counties. The application also included a request to change the name on CCN No. 21086 from Crystal Clear Water Supply Corporation to Crystal Clear Special Utility District. On July 31, 2020, State Office of Administrative Hearings Order No. 3 was filed, severing the issue of the uncontested name change from this case and remanding that issue to the Public Utility Commission (Commission).

I. MOTION FOR DOCKETING

Commission Staff requests that the Office of Policy and Docket Management open a new docket to allow the Commission to begin processing Crystal Clear's uncontested request for a name change that has been severed from Docket No. 49926 and remanded to the Commission.
