COMMISSION STAFF'S PROPOSED PROCEDURAL SCHEDULE

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and in response to Order No. 5, files this Supplemental Recommendation on Administrative Completeness and Proposed Procedural Schedule. In support thereof, Staff shows the following:

I. BACKGROUND

On September 17, 2019, Pure Utilities, LC (Pure) and Undine Texas, LLC (Undine), (collectively, Applicants), filed an application for the sale, transfer, or merger of facilities and certificate rights in Liberty, Polk, San Jacinto and Tyler Counties. The Applicants seek to transfer Pure's water systems and transfer the related portion of the water service area held under certificate of convenience and necessity (CCN) No. 12072 to Undine's CCN No. 13260. The requested transfer includes approximately 5,095 acres and 1,059 current customers.

On March 13, 2020, Order No. 5 was issued finding Applicants' notice sufficient and requiring Staff to file a proposed procedural schedule for further processing of the application by March 27, 2020. Therefore, this pleading is timely filed.

II. PROCEDURAL SCHEDULE

Staff proposes the following procedural schedule:
