The Tri Try WSC filed an application to obtain a Water Certificate of Convenience and Necessity in Stonewall County. **This submittal addresses requirements outlined by the PUC on April 27, 2020, Item #16 of Docket # 50042.** These requirements are for the submittal of the direct notice and publisher's affidavits. These affidavits have been signed and included in this filing. The filing also includes new shape files and maps as a result of a reduction of the CCN area at the request of the City of Aspermont City Manager due to City water services in the area. The overall area is reduced to 19,718.19 Acres as a result of this change.


