COMMISSION STAFF'S REQUEST FOR EXTENSION

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Commission Staff's Request for Extension. In support thereof, Staff would show the following:

I. BACKGROUND

On September 23, 2019, Tri Try Water Supply Corporation (Tri Try WSC) filed an application to obtain a water certificate of convenience and necessity (CCN) in Stonewall County under Texas Water Code (TWC) §§ 13.242 to 13.250 and 16 Texas Administrative Code (TAC) §§ 24.225 to 24.237. Tri Try WSC filed supplemental information on November 19, 2019, January 23, 2020, March 17, 2020, and March 25, 2020. On June 1, 2020, and June 9, 2020, Tri Try WSC filed maps and affidavits attesting to the provision of notice.

On April 27, 2020, Order No. 5 in this proceeding was issued, requiring Staff to file a recommendation on the sufficiency of notice by June 15, 2020. Therefore, this pleading is timely filed.

II. REQUEST FOR EXTENSION

Under 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff has been in contact with Tri Try WSC and understands that after receiving notice of the application, the City of Aspermont opted out of the requested area. Accordingly, the notice documents and maps filed on June 1, 2020 and June 9, 2020 reflect a corresponding reduction in the size of Tri Try WSC's requested area. Because Staff cannot make a recommendation on the sufficiency of notice until Staff has reviewed the revised mapping data, Staff requests additional time to conduct its analysis. Accordingly, Staff requests that a July 15, 2020 deadline be established for Staff to file a supplemental recommendation on the sufficiency of the application and notice.

III. CONCLUSION

Staff respectfully requests that a July 15, 2020 deadline be established for Staff to file a supplemental recommendation on the sufficiency of the application and notice.
