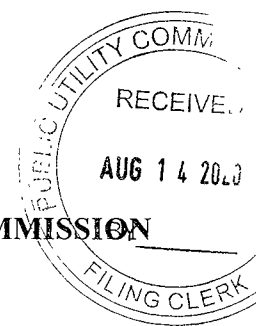

COMMISSION STAFF'S REQUEST FOR REVISED PROCEDURAL SCHEDULE

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Commission Staff's Request for Revised Procedural Schedule. In support thereof, Staff would show the following:

I. BACKGROUND

On September 23, 2019, Tri Try Water Supply Corporation (Tri Try WSC) filed an application to obtain a water certificate of convenience and necessity (CCN) in Stonewall County under Texas Water Code (TWC) §§ 13.242 to 13.250 and 16 Texas Administrative Code (TAC) §§ 24.225 to 24.237. Tri Try WSC filed supplemental information on November 19, 2019, January 23, 2020, March 17, 2020, and March 25, 2020. On June 1, 2020, June 9, 2020, and June 18, 2020 Tri Try WSC filed maps and affidavits attesting to the provision of notice.

On July 27, 2020, Order No. 7 in this proceeding was issued, establishing a procedural schedule and requiring Staff to provide a copy of the final map, tariff, and certificate for Tri Try WSC's consent by August 14, 2020. Therefore, this pleading is timely filed.

II. REQUEST FOR REVISED PROCEDURAL SCHEDULE

Under 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff has been in communication with Tri Try WSC to obtain information necessary for Staff to provide Tri Try WSC with a tariff for consent. To allow time for Staff to obtain this information and properly draft a tariff for consent, Staff respectfully requests that the deadline to provide Tri Try WSC with a copy of the final map, certificate, and tariff be extended until August 28, 2020 and that the remainder of the procedural schedule be revised as follows:

Event	Deadline
Deadline for Commission Staff to provide final maps, certificates, and tariffs (if applicable), to applicant for review and consent	August 28, 2020
Deadline for applicant to file signed consent forms with the Commission	September 4, 2020
If no hearing is requested, deadline for Commission Staff to file a final recommendation on the application	September 11, 2020
If no hearing is requested, deadline for parties to file joint proposed findings of fact and conclusions of law	September 18, 2020

III. CONCLUSION

Staff respectfully requests that the foregoing revised procedural schedule be adopted.
