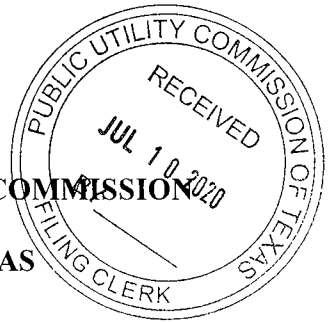

**COMMISSION STAFF'S REQUEST FOR EXTENSION**

**COMES NOW** the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this request for extension. In support thereof, Staff shows the following:

**I. BACKGROUND**

On October 9, 2019, Solar Village Homeowners Association (Solar Village) filed an application to obtain a water Certificate of Convenience and Necessity (CCN) in Kerr County. The requested service area consists of 17 acres and has 15 customers connections.

On April 29, 2020, the Commission Administrative Law Judge (ALJ) issued Order No. 4, establishing July 13, 2020, as the deadline for parties to file joint proposed findings of fact and conclusions of law. Therefore, this pleading is timely filed.

**II. REQUEST FOR EXTENSION**

Pursuant to 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. As a result of the application, a portion of the City of Kerrville's (the City) water CCN will be decertified. The City has agreed to the decertification. However, Staff requests additional time to obtain consent from the City of Kerrville to the proposed map and certificate memorializing the decertification and respectfully requests an extension of time until August 14, 2020.

**III. CONCLUSION**

Staff respectfully requests that the deadline to file to file proposed findings of fact and conclusions of law be extended to August 14, 2020.
