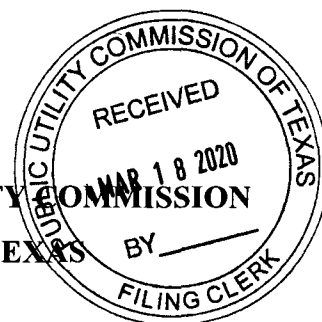

COMMISSION STAFF'S REQUEST FOR EXTENSION

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Request for Extension. In support, Staff shows the following:

I. BACKGROUND

On October 23, 2019, Madera Valley Water Supply Corporation (Madera Valley WSC) and Town of Pecos City (Pecos City) filed an application for the sale, transfer, or merger of facilities and certificate rights in Reeves County. Specifically, Madera Valley WSC seeks to sell a portion of its facilities and transfer a portion of its water service area held under certificate of convenience and necessity (CCN) No. 10240 to Pecos City. Pecos City's water CCN No. 10945 will be amended. The requested area includes approximately 11,112.79 acres and 66 connections.

On January 24, 2020, the application and notice having been found sufficient, the administrative law judge (ALJ) issued Order No. 4, which established a deadline of February 19, 2020 for Staff to file a recommendation on the approval of the sale or request a hearing. On February 19, 2020, Staff recommended that the transaction be allowed to proceed. Order No. 4 also established March 18, 2020 as the deadline for the Parties to file a joint motion to admit evidence and proposed order approving sale/transfer to proceed. Therefore, this pleading is timely filed.

II. REQUEST FOR EXTENSION

Pursuant to 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff and Applicants are in the

process of finalizing a joint motion to admit evidence and proposed order approving sale/transfer to proceed as required by Order No. 4.

As such, Staff requests that the deadline for the parties to file their joint motion to admit evidence and proposed order approving sale/transfer to proceed be extended to March 23, 2020.

III. CONCLUSION

For the reasons discussed above, Staff respectfully requests that the ALJ grant an extension of time for the parties to file their joint motion to admit evidence and proposed order approving sale/transfer to proceed.


