COMES NOW the Greenwood Water Corporation ("Greenwood"), and files this Response to Order No. 1 and would show the following:

On October 30, 2019, the Administrative Law Judge issued Order No. 1 requiring Greenwood to supplement its application with additional information on or before November 18, 2019. Therefore, this pleading is timely filed.

### **Applicant Information**

- 1. The legal name under which Greenwood conducts business is Greenwood Water Corporation. Greenwood does not use any assumed names.
- Greenwood is a Texas corporation that was formed on March 15, 1982. Greenwood's Texas Secretary of State file number is 60027600. The franchise tax account status information for Greenwood is attached as Exhibit A.
- 3. The parent company of Greenwood is Permian Basin Water Resources, LLC ("Permian"). Permian is a Delaware limited liability company having a formation date of May 23, 2014. Permian was registered with the Texas Secretary of State on October 10, 2019. Permian's Texas Secretary of State File No. is 803442273. The franchise tax account status information for Permian is attached as Exhibit B. The primary business interest of Permian is ownership of public utility companies. Greenwood has two affiliated companies: Park Water Company and Park Sewer Company, both of which are Texas corporations. Greenwood does not currently conduct any business with Park Water Company or Park Sewer Company.
