RE: Applications of RWE Entities to Amend REC Certifications

To Whom it May Concern:

On October 28, 2019, in the control numbers listed below, renewable energy credit (REC) generator certificate holders owned by RWE Renewables Americas, LLC (RWE) (collectively, Applicants), filed applications to amend their respective certificates. The Applicants intent was to update the contact information on each certificate. As initially filed, the applications listed "RWE Renewables Americas, LLC" as the "Name of Owner" listed under Item No. 3 for each applicant, because RWE is the ultimate parent company owner and the active manager of each applicant.

After speaking with PUCT staff, the Applicants are submitting amended pages for each REC generator certificate amendment application, listing the REC generator certificate holder as the "Name of Owner" listed in Item No. 3., rather than RWE, the ultimate upstream owner. I can confirm that nothing has changed with respect to each applicant's facility or its eligibility for Renewable Energy Credits. Each of the Applicants remain the owner of its respective PUC Registration as a Power Generation Company (PGC).
