COMMISSION STAFF'S RECOMMENDATION ON SUFFICIENCY OF NOTICE

On October 28, 2019, the City of Aubrey (Aubrey) filed an application to amend its certificates of convenience and necessity and to decertify portions of Mustang Special Utility District's service areas in Denton County. On February 5, 2021, the administrative law judge (ALJ) filed Order No. 9 establishing a deadline for Staff of the Public Utility Commission of Texas (Staff) to file a recommendation on sufficiency of notice and propose a procedural schedule by March 5, 2021. Therefore, this pleading is timely filed.

I. NOTICE

Staff recommends that the applicant's notice be found sufficient. In Order No. 9, the ALJ found Aubrey's notice insufficient due to an error found by Staff and Aubrey and ordered Aubrey re-issue the corrected notice to the Upper Trinity Water Supply District. On February 12, 2021, Aubrey submitted the affidavit of Jenny Huckabee stating that notice had been reissued to the Upper Trinity Water Supply District and provided an example of the corrected notice with the attached maps. Therefore, Staff recommends that Aubrey has substantially met the requirements of 16 Texas Administrative Code § 24.235 and that Aubrey's notice be found sufficient.

II. PROPOSED PROCEDURAL SCHEDULE

Consistent with Staff's sufficiency recommendation, Staff proposes the following procedural schedule:

Deadline for Staff to provide final maps, certificates, and tariffs (if applicable), to Aubrey for review and consent	April 9, 2021		
Deadline for Aubrey to file signed consent forms with the Commission	April 23, 2021		
If no hearing is requested, deadline for Staff to file a final recommendation on the Application	May 7, 2021		
If no hearing is requested, deadline for parties to file joint proposed findings of fact and conclusions of law	May 21, 2021		

III. CONCLUSION

For the reasons detailed above, Staff recommends that the notice provided be deemed sufficient and respectfully requests the proposed procedural schedule be adopted.

¹ Pursuant to 16 TAC § 24.235(a)(3), the intervention deadline is 30 days after the mailing or publication of notice, whichever occurs later. Notice was mailed on February 8, 2021 and published on December 20, 2021 and December 27, 2021. Therefore, 30 days after February 8, 2021 is March 10, 2021.
