MOTION FOR LEAVE AND/OR GOOD CAUSE EXCEPTION TO ADDRESS NOTICE ISSUES

Timbercrest Partners LLC (Timbercrest) files this Motion for Leave and/or Good Cause Exception to address notice to the Office of Public Utility Counsel and, in support thereof, respectfully shows as follows:

1. Introduction

On January 17, 2020, Timbererest filed an application with the Public Utility Commission of Texas (Commission) for authority to change its retail water and sewer rates under Texas Water Code (TWC) §§ 13.1871 and 13.1872(c)(2) and 16 Texas Administrative Code (TAC) §§ 24.25-.44. There were no protests or interventions filed in this case.

On March 3, 2023, Timbercrest and Staff filed its Unanimous Stipulation and Settlement Agreement, along with Joint Proposed Order and Proposed Tariffs. On April 12, 2023, the parties filed, contemporaneously with this Motion, an Amended Unanimous Stipulation and Settlement Agreement.

On March 31, 2023, Commission Counsel filed memoranda, requiring Timbercrest and Staff (the "Parties") to address certain evidentiary issues and notice to affected municipalities and the Office of Public Utility Counsel ("OPUC") by April 4, 2023. On April 4, 2023, Commission Counsel granted the Parties an extension to make these filings until April 12, 2023. Therefore, this pleading is timely filed.

II. Motion for Leave or Good Cause Exception

A. Notice to Affected Municipalities

As noted in Timbercrest's proof of notice of the prehearing conference (Interchange Item No. 55), there are no affected municipalities. Attached hereto as Exhibit A is a supplemental proof of notice attesting to the fact that there are no affected municipalities.

B. Notice to Office of Public Utility Counsel

Timbercrest respectfully requests leave to provide late notice to the Office of Public Utility Counsel in this matter. This case was originally filed over three years ago. Counsel for Timbercrest was under the impression that notice was provided to OPUC at the time of filing. However, other than a general reference to a mailing label in its files, Timbercrest cannot find proof that notice was actually mailed. Timbercrest has now provided notice to Office of Public Utility Counsel and is awaiting a response as to whether they previously received notice and whether they wish to intervene

in this proceeding. Timbercrest moves for leave to late file this notice for good cause and requests that the Commission allow time for OPUC to respond to the notice through intervention or notice that it does not wish to intervene.

Good cause exists for the late filing. Timbercrest's failure to provide notice was not intentional. Counsel for Timbercrest was under the impression that notice had been provided to OPUC. As discussed above, this case has been on file for over three years. There were no protests filed in the case. This is a small Class D water utility with only 5 metered customers. Commission Staff issued eleven sets of RFIs in this case, and a technical conference/mediation took place. It was only after the thorough review of Staff that the parties were able to reach a resolution. For this reason, the public interest has been served in this case and a good cause exception would be warranted.
