**COMMISSION STAFF’S SEVENTH STATUS REPORT**

On January 17, 2020, Timbercrest Partners, LLC (Timbercrest) filed an application for authority to change its retail water and sewer rates under Texas Water Code (TWC) §§ 13.1871 and 13.1872(c)(2) and 16 Texas Administrative Code (TAC) §§ 24.25-44.

On July 12, 2021, the administrative law judge (ALJ) issued SOAH Order No. 3 requiring the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a status report on abatement on the 15<sup>th</sup> of each month beginning September 15, 2021. Therefore, this pleading is timely filed.

**I. STATUS REPORT**

This docket was referred to mediation on July 12, 2021, and the Parties are working with the mediator to schedule dates for mediation. Further, Staff is working with Timbercrest to get the necessary information to have a productive mediation. Staff requests that this docket continue to be abated so that the Parties can engage in mediation.

**II. CONCLUSION**

Staff respectfully requests that the docket continue to be abated and will provide another status report on April 15, 2022 in compliance with SOAH Order No. 3.
