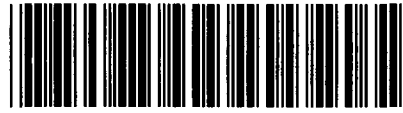

To Whom It May Concern:

We are residents of Country Vista Estates located in Burleson, Texas. Our neighborhood utilizes a private wastewater service, presently owned and operated by Undine Texas, LLC ("Undine"). We are current ratepayers of Undine for the services it renders. We are writing to PROTEST the Notice of Proposed Rate Change (CCN Number 21019; PUCT Docket No. 50200) dated on or about December 20, 2019 and filed with the PUCT.


We feel that Undine is requesting an unfair and unreasonable rate increase. We have concerns that Undine may be requesting the increase in contravention of PUCT rules and regulations. We are requesting a Contested Case Hearing regarding this rate increase, and also request that any such hearing be conducted, if possible, in Johnson County, TX as opposed to Austin, TX, to allow us and other concerned residents of Country Vista Estates to attend the hearing at a venue more accessible to the affected parties.


