
On or about January 23, 2020, the Town of Dennis Texas and its ratepayers protested the Undine Rate Request for Sewer Service. Following that notice of protest, counsel for Undine provided a packet to review. Please accept this letter as continued notice of protest to the Undine Rate Request for Sewer Service for the residents of the Town of Dennis. Undine has furnished no justification as to the rate increase benefitting our residents and its customers and the "one size" rate increase for all its customers does not give notice as to what or how the rate increase is justified or how it will be used. The proposed rate is almost sixty percent (60%) of the current flat rate.

In the packet, it lists improvements Undine intends to make but offers no specifics how Dennis will benefit or what will be done for Dennis. Additionally the salaries of Undine management groups are exorbitant and the rate payers should not be saddled with management salaries that total over 3 million dollars.
