

Staff 2-1 Reference Schedule WP-III-2, Orbit tab, Line 935, Transmission and Distribution Plant, Various, Net Plant: \$9,955.19. Provide receipts or an explanation and including the calculation for the Net Plant amount.

**RESPONSE:** The \$9,955.19 of net plant is based on the original inventory amount of \$11,884.73 less depreciation of \$1,929.54. Accumulated depreciation was calculated by taking the age at 9/30/19 of 3.2471 yrs. divided by the average life for Services of 20 years and multiplying by the original cost of \$11,884.73. The original inventory for Orbit was provided in response to OPUC 1-13.
