

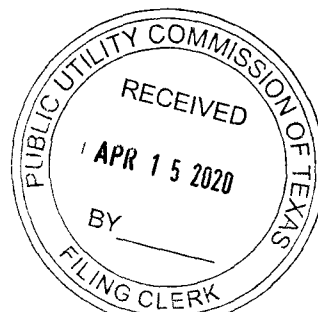



Intervenors request that all pleadings, correspondence, and filings, including discovery response be served on their authorized representative identified above.




