## SOAH ORDER NO. 3 CONVERTING PREHEARING CONFERENCE TO VIDEOCONFERENCE

Pursuant to State Office of Administrative Hearings (SOAH) Order No. 1, a prehearing conference is scheduled to convene **at 10:00 a.m., June 2, 2020**, in Austin, Texas. On March 13, 2020, Texas Governor Greg Abbott declared a state of disaster regarding the novel coronavirus (COVID-19). In response to the emergency declarations regarding COVID-19, SOAH has temporarily suspended all non-emergency, in-person hearings.<sup>1</sup> It is not known the extent to which in-person hearings will resume after June 1, 2020. Therefore, in order to ensure that the prehearing conference is not delayed, it is **ORDERED** that the prehearing conference will convene **via Zoom videoconference at 10:00 a.m. on June 2, 2020**. To assist the Administrative Law Judges (ALJs) in this process, each party or potential party is encouraged to select one person to participate on its behalf.

**Participation instructions for this specific prehearing conference are found at the end of this Order.** To participate in the prehearing conference, you will need: (1) a computer with a functional webcam and microphone (preferred method); (2) any smart device, such as iPad, iPhone, or Android phone; or (3) a mobile or landline telephone. Additionally, the ALJs believe that allowing the parties to speak with a SOAH mediator could potentially be helpful. Therefore, after the prehearing conference is concluded, if the parties wish to speak with a SOAH mediator, one will be available to discuss mediation, which is free of
