



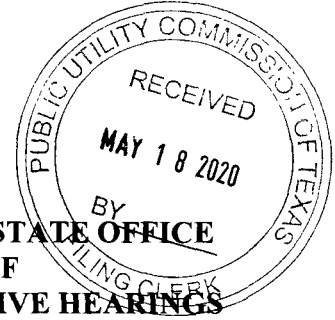

- Staff 7-3** Reference the response to Staff 1-7. Please provide the number of customers that individually represent more than 10% of UT or UTE's total revenues. Please list the percentage of total revenues each individual customer represents and identify which entity, UT or UTE, the customer receives service from.
- Staff 7-4** Reference the response to Staff 1-8. Please provide all documentation supporting the statement that Udine has "exemplary customer service."
- Staff 7-5** Reference the response to Staff 1-8. Please identify each repair made since acquisition that has brought a system included in the application into compliance with TCEQ standards.
- Staff 7-6** Reference bates page 121 and WP-III-2 of the Application. Please provide all documentation supporting the ADFIT determination.
