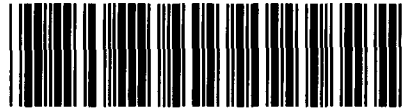

In support of its Motion, POA shows as follows:

1. POA is a Home-Owners Association located within the service territory of UNDINE TEXAS, LLC AND UNDINE TEXAS ENVIRONMENTAL, LLC (Undine) whose residents are affected by this filing.
2. On December 20, 2019, Undine filed an application for authority to change rates. POA's residents may be adversely impacted by Undine's request. Therefore, POA has a justiciable interest in this proceeding pursuant to Water Code §13.042 and 16 Texas Administrative Code (TAC) §22.103(b). Therefore, POA has standing to participate in this proceeding that is conferred by statute.
