Staff 6-1 Please refer to Schedule VI-4 and excel file "WP I-2(a), I-2(B) and I-3."

- i. Provide all workpapers supporting Undine's test-year billing units used to calculate each of Undine's proposed volumetric rates in native excel format. Please include workpapers supporting the calculation of test-year billing units for each of the water rate schedules that Undine proposes to consolidate in this proceeding.
- ii. For each of the water rate schedules that Undine proposes to consolidate in this proceeding, please provide all workpapers supporting the segmentation of test-year billing determinants into the various volumetric rate blocks that are being proposed in this proceeding.

**RESPONSE:** The usage for the test year was taken from the billing registers and summarized in voluminous **Attachment Staff 6-1(i).** By using those same billing registers and categorizing the customer usage into the rate blocks for usage from 0 gallons up to 6,000 gallons, 6,001 gallons up to 15,000 gallons, 15,001 gallons up to 25,000 gallons, and over 25,000 gallons, the rate block billing determinants were derived.

The details of the rate block billing determinants are voluminous. However, a summary is provided in voluminous Attachment Staff 6-1(ii) and confidential voluminous Attachments Staff 6-1(ii) for each system. Adjustments were made for Gulf Coast (Cold River Ranch and Southwood Estates) to add back up to 2,000 gallons included in the base rate to get total gallons. Also, the 2020 Budget for Gulf Coast Water and Chuck Bell Water were used instead of the partial year of actual data. The 2020 Budget for Gulf Coast Water and Chuck Bell Water utilized average actual historical usage data for all periods in which the data was readily available, so Undine believes it results in the best calculation for annual usage. The Gulf Coast Water and Chuck Bell Water systems detailed 2020 Budgets were provided in response to the attachment to OPUC 3-1.

Staff 6-2 Please explain the rational for allocating return on rate base between fixed and variable costs based on the fixed/variable split of Undine's expenses.

**RESPONSE:** The fixed/variable split of the revenue requirement is based on those costs that vary with consumption and those that do not. Since return on rate base relates to the total revenue requirement and is not specifically related to either fixed or variable costs, the fixed/variable split of all other expenses was used to allocate return on rate base.

- i. Provided a detailed breakdown of all costs that were directly assigned to sewer or water, and all costs that were allocated between sewer and water. Provide all workpapers supporting your response in native excel format.
- ii. For all costs that were not directly assigned to sewer or water, provide all workpapers supporting the allocation factors used to allocate these costs in native excel format.

#### **RESPONSE:**

All costs are directly assigned to the system to which they belong except certain accounts for Orbit water and wastewater and Gulf Coast water and wastewater. Both Orbit and Gulf Coast have certain categories of costs allocated to Water and Wastewater based on ERCs. These categories include Account 634.7/734.7, Billing and Customer Service, Account 637/737, Printing and Postage, Account 639/739, Work Order System Fees, Account 657/757, Insurance – General Liability, Account 659/759, Insurance – Other, and Account 675.1/775.1, Banking Fees – Other. Also, Gulf Coast rents the property for both the water plant and wastewater treatment plant sites. This rent expense is allocated 50% to water and 50% to wastewater.

During 2018, the Orbit general ledger had both water and wastewater included in it, with many 6xx-level water accounts and many 7xx-level wastewater accounts shown separately. During 2019, all expenses for Orbit were broken out into separate water and wastewater accounts. For this rate application, the Orbit expenses for October 2018 through December 2018 had to be allocated between water and wastewater accounts in order for these expenses to be shown properly as either water or wastewater.

Please refer to Attachment Staff 6-3 for those expenses that were allocated between water and wastewater for this rate application. All other expenses were directly assigned to the appropriate water or wastewater accounts.
