**COMMISSION STAFF'S SUPPLEMENTAL RECOMMENDATION ON SUFFICIENCY
OF THE CLOSING DOCUMENTS**

On November 6, 2019, the City of Wolfforth and Aim Water Company, LLC (collectively, the Applicants) filed an application with the Public Utility Commission of Texas (Commission) for approval of the sale, transfer, or merger of facilities and certificate rights in Lubbock County. On November 10, 2020, the Applicants filed closing documents to demonstrate completion of the sale. On January 20, 2021, the Applicants filed supplemental closing documents including a bill of sale and proof that affected customer deposits were properly transferred or refunded.

On December 16, 2020, Order No. 11 in this proceeding was filed, requiring Commission Staff (Staff) to file a supplemental recommendation on sufficiency of the closing documents by February 10, 2021. Therefore, this pleading is timely filed.

I. STAFF'S RECOMMENDATION

Staff has reviewed the Applicants' closing documents as supplemented and recommends that the Applicants have properly addressed all deficiencies listed in Staff's December 16, 2020 recommendation. Accordingly, Staff recommends that the closing documents be found sufficient as supplemented.

II. PROPOSED PROCEDURAL SCHEDULE

Staff recommends that the Applicants' closing documents be found sufficient as supplemented. Therefore, Staff proposes the following procedural schedule:

Event	Date
Deadline for Staff to provide final maps, certificates, and tariffs (if applicable) to Applicants for review and consent	March 10, 2021
Deadline for Applicants to file signed consent forms with the Commission	March 25, 2021
Deadline for parties to file joint proposed findings of fact and conclusions of law	April 9, 2021

III. CONCLUSION

Staff recommends that the Applicants' proof of closing documents be found sufficient as supplemented and that the above-proposed procedural schedule be adopted. Staff respectfully requests that an order be issued consistent with the foregoing recommendations.
