1. On February 12, 2020, Order No. 3 was entered in the above matter. In that Order, the Administrative Law Judge found the Application filed herein to be incomplete and requested supplementation on or before April 10, 2020. This Order was entered pursuant to the Commission Staff's Supplemental Recommendation on Administrative Completeness which was filed on February 10, 2020.

2. The Commission has requested, and the Judge directed, that certain supplemental mapping be submitted to the Commission.
