ASSIGNMENT AND TRANSFER OF CERTIFICATE OF CONVENIENCE AND NECESSITY RIGHTS

KNOW ALL PERSONS BY THESE PRESENTS:

COUNTY OF McLENNAN

WHEREAS, the CITY OF BRUCEVILLE-EDDY, TEXAS, as Transferor, and ELM CREEK WATER SUPPLY CORPORATION, as Transferee, have made application with the Public Utility Commission of the State of Texas to approve the assignment and transfer of certain Certificate of Convenience and Necessity ("CCN") rights; and

WHEREAS, the Application of Bruceville-Eddy and Elm Creek Water Supply was assigned Docket No. 50224 before the Public Utility Commission of Texas; and

WHEREAS, the subject of said Application was the transfer and assignment of a small portion of the Bruceville-Eddy CCN (as described on <u>Exhibit "A"</u>) to Elm Creek Water Supply Corporation; and

WHEREAS, on September 4, 2020, Administrative Law Judge Steven Leary entered Order No. 7 Approving Sale and Transfer to Proceed in Docket No. 50224;

NOW, THEREFORE, the City of Bruceville-Eddy, Texas for One Dollar (\$1.00) and other good and valuable consideration, does hereby assign, convey and transfer unto Elm Creek Water Supply Corporation, its successors and assigns, all of its rights under CCN No. 11285 to provide water service to the area described in Exhibit "A". Henceforth, the right to provide water service to this area and the corresponding obligations under state law shall belong to Elm Creek Water Supply Corporation. If necessary, the City of Bruceville-Eddy agrees that from time to time and upon request of Elm Creek Water Supply Corporation to execute and deliver such other instruments of assignment and transfer and to take any such other actions as may be reasonably necessary to assign and transfer the rights as described herein.

This Assignment and Transfer of Certificate of Convenience and Necessity Rights is executed on this the <u>lith</u> day of <u>September</u>, 2020.


